Local Attorney Inducted to Football Hall of Fame for Second Time

Fort Myers, FL: For the second time in five years local real estate attorney, Kevin F. Jursinski, along with his teammates of the 1966 Lorain St. Mary Fighting Irish Football Team, is inducted into the Lorain (Ohio) Sports Hall of Fame.

Jursinski, a starter on the 1966 Lorain St. Mary Fighting Irish football team, was undefeated at 9-0 that year, and outscored its opponents 279-86 during the season.

Jursinski was also a linebacker and defensive captain on the undefeated 1967 Lorain St. Mary Fighting Irish football team, which was inducted into the Lorain Sports Hall of Fame in May of 2005. The 1967 team, which outscored its opponents 279-26 over a nine (9) game span was undefeated and holds the all-time Lorain County football winning streak record of 24 consecutive undefeated games.

“Our coaches taught us always to strive for victory and never accept defeat,” says Jursinski. “That mentality guided me through my football career and now through my career as an attorney.”

The 1966 and 1967 Lorain St. Mary Fighting Irish Football Team, on which Jursinski played, scored 578 points and only gave up 112. During his senior year, Jursinski’s team outscored their opponents more than 10 to 1.

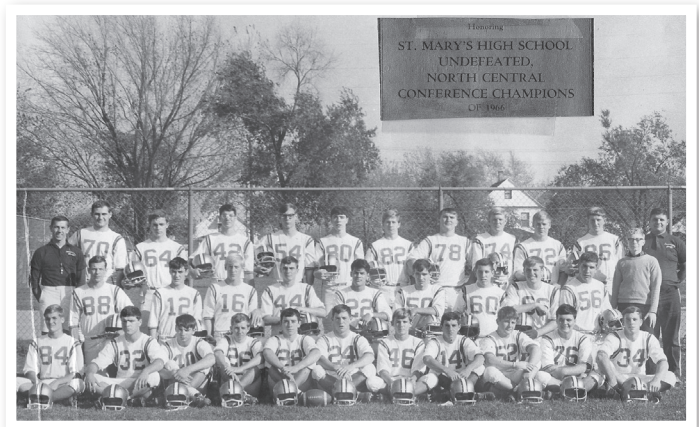
